CALL FOR EXPRESSIONS OF INTEREST: CHARTERED ACCOUNTANT FIRMS FOR THE STATUTORY AUDIT OF SIKKIM STATE AIDS CONTROL SOCIETY AND INTERNAL AUDIT FOR NGOs AND PERIPHERALS

- 1. The State AIDS Control Societies (SACS) are responsible for implementing the National AIDS Control Programme (NACP) Phase V in the States. The main strategies of NACP-V under National AIDS Control Organization are intensifying and consolidating prevention services, with a focus on HRGs and vulnerability population, increasing access and promoting comprehensive care, support and treatment, expanding IEC services for a general population and high risk groups with a focus on behavior change and demand generation ,building capacities at national,state,district and facility levels, strengthening strategic information management systems. SACS is a registered organization under the control of the State Government and it the nodal organization for all the HIV/AIDS prevention and control work that is taken up in the state. SACS releases fund to peripheral organizations like NGOs and hospitals under the Government sector. Hence it is essential to assess as to conduct a statutory audit under the provision of the Societies Registration Act, 1860 as applicable in the State.
- 2. Expressions of Interest are invited from CAG empanelled Chartered Accountant firms to conduct the statutory audit of the SACS and internal audit of NGOs for a financial year 2024-25, 2025-26 and 2026-27.

ELIGIBILITY & ASSESSMENT CRITERIA:

The EoI and capability will be assessed against evidence of skills and experience in providing accountancy services in the state.

REQUIREMENTS

The EoI should be sent along with a capability Statement including a profile of the organization, relevant technical and geographical coverage along with the financial turnover for the last 3 financial years. Individual CVs are not required at this stage. Any EoI with inadequate information, those which do not meet the above criteria, or those received after the closing date will not be short listed. EoI should be as concise and focused as possible to give evidence of the above requirements including the capability statement and organization profiles. They should be sent by post to the Project Director, SIKKIM STATE AIDS CONTROL SOCIETY, SOCHAYGANG, STNM HOSPITAL, GANGTOK, SIKKIM-737101 to arrive no later than 12 noon on 15th March 2025 . Only organizations, which pass the pre-selection process, will be contacted and invited to submit detailed proposals.
